

## **SUMMARY ANNUAL REPORT FOR RADIOLOGY PARTNERS INC. HEALTH AND WELFARE PLAN**

This is a summary of the annual report of the RADIOLOGY PARTNERS INC. HEALTH AND WELFARE PLAN, a health, life insurance, dental, vision, temporary disability, prepaid legal and long-term disability plan (Employer Identification Number 46-1413340, Plan Number 501), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has insurance contracts with METROPOLITAN LIFE INSURANCE COMPANY, METLIFE LEGAL PLANS, HAWAII MEDICAL SERVICE ASSOCIATION and 98POINT6 to pay certain Health, Accident, Critical Illness, Legal, Hospital Indemnity, and Virtual Care claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$1,008,321.
