## Basic Term Life

100% Employer Paid

- ▶ Basic Term Life - You are automatically enrolled for 2 times your covered annual earnings to \$400,000. **Please refer to your plan certificate(s) to review the required minimum and maximum coverage amounts allowed.**
- ▶ Basic Dependent Term Life - Your Spouse/Same and Opposite Sex Domestic Partner is automatically enrolled for \$10,000. **Please Note:** The Basic Dependent Term Life coverage amount cannot exceed 100% of your Basic Term Life coverage amount.
- ▶ Basic Dependent Term Life- Your child(ren) is automatically enrolled for \$5,000. **Please Note:** The Basic Dependent Term Life coverage amount cannot exceed 100% of your Basic Term Life coverage amount.
- ▶ Child coverage begins at live birth and continues to 26, if unmarried.
- ▶ If you are terminally ill, you can get a partial payment of your group life insurance benefit. You can use this payment as you see fit. The payment to your beneficiary will be reduced by the amount you receive with the Accelerated Benefit Option.\* Refer to the plan booklet for details
- ▶ Payment of premium can be waived if you are totally disabled for 6 months, you are less than 60 years old when the disability begins, and you continue to be totally disabled. This waiver terminates at age 65. This provision may vary by state.
- ▶ Coverage will be reduced as you age – by 50% at age 70.
- ▶ You may convert your insurance to an individual life insurance policy issued by the Prudential Insurance Company of America, or you may be eligible to port your coverage ending to a separate group term life contract.

## Basic Accidental Death & Dismemberment

- ▶ Basic Accidental Death & Dismemberment pays you and your beneficiary a benefit for the loss of life or other injuries resulting from a covered accident — 100% for loss of life and a lesser percentage for other injuries. For your coverage to become effective, you must be actively at work on the effective date of the plan. If you apply for an amount that requires satisfactory evidence of insurability to The Prudential Insurance Company of America, you must be actively at work on the date of approval for the amount requiring satisfactory evidence of insurability.

<sup>1</sup>Elections made outside of approved enrollment events and elections exceeding the guaranteed issue amount may require proof of good health. Employees previously declined coverage must also provide proof of good health.
