<b>What is the overall <a href="#">deductible</a>?</b>	<b>\$4,000</b> /individual or <b>\$8,000</b> /family for <a href="#">Network Providers</a> . <b>\$8,000</b> /individual or <b>\$16,000</b> /family for Non- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .  This HRA account reimburses you for certain deductibles and coinsurance amounts up to <b>\$1,000</b> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. <a href="#">Preventive care</a> for <a href="#">Network Providers</a> .
